Message from our Executive Director

Dear Romero Institute Family,

In 2020, thanks to your generous support, the Romero Institute — home to Lakota People's Law Project, Greenpower, and now Let's Green CA — made great strides in our fight for Indigenous rights and for bold solutions to climate change.

Despite the challenges presented by the pandemic, together we made important impacts — on Lakota Country, California, and the nation.

We continued our long-standing opposition to pipelines and the fossil fuel industry — which yielded huge results in 2021. But first, we kicked things off on a high note by opening a much needed Lakota-run foster home for vulnerable Standing Rock youth.

Our energy then shifted to pressing and timely needs at hand. We kept families safe from Covid-19 in Lakota Country by protecting tribal health and safety checkpoints against legal and financial threats by Governor Noem and President Trump.

Knowing that the outcome of the 2020 election would determine the future of environmental and Native justice issues, we teamed up with the Standing Rock Sioux Tribe to create a professional phone bank that ensured underrepresented voices were heard loud and clear at the polls. Tens of thousands of calls made by Standing Rock citizens to swing state voters made a definitive difference in Arizona and Georgia!

Our team at Romero remained dedicated to our vision of California as the state that can lead the nation into responsible, faster climate policy. The fires across the west catapulted the climate emergency to the forefront, showing that climate denial and half-measures must be replaced with bold, timely solutions. Though fires, evacuations, and the pandemic impeded our progress on these California initiatives, we pressed forward with research and alliance-building, ultimately drafting a bill presenting a path to comprehensive, climate solutions and environmentally-just reform.

Greenpower, now rebranding as Let's Green CA, made the most of the social distancing era by producing powerful, virtual events for leaders in state policy, education, and business. These Central Coast Climate Summit sessions will help make just climate solutions a reality across our region.

In this annual report, you will discover more highlights of our 2020 program work and gain insights into our program impacts, financials, and goals moving forward, all of which happen because of your generous support. Thank you for walking with us on this sacred journey.

We protect constitutional rights, treaty rights, human rights, and the environment. We champion equity and advocate for the people.



Only bold and comprehensive solutions can turn the tide on the climate emergency. At Romero Institute, we are advocating for a carbon-free future through the creation of a Green New Deal for California. In 2020, we brought on a top-notch campaign consultant, built an advisory board, reached out to allied organizations for their collaboration, secured experts throughout the state to assist us in assembling legislation, and hired an experienced politician to draft a bill and guide us in our relations with the state legislature. The California Green New Deal we are working towards will lead with environmental justice, achieve carbon neutrality by 2035, and generate green jobs in a thriving clean energy economy.

In 2016, inspired by Pope Francis' call to "care for our common home," and by the climate crisis our planet faces, the Romero Institute launched **Greenpower**. In California, we've gathered an alliance of organizations and jurisdictions to create a carbon-free Central Coast, and we've expanded our focus to prioritize statewide action. Through the power of community organizing and targeted outreach, we implement localized solutions to the global climate emergency.

Mission:

Greenpower is growing a movement to restore the Earth's climate by helping California transition from fossil fuels to local, community-based green energy systems. We empower people to go from apathetic resignation to energized action. We work with elected officials, fellow activists, and allied organizations, allowing us to quickly maximize impact. We believe that saving the planet is humanity's most important social and spiritual imperative.



Greenpower has taken the lead on building a powerful, region-wide coalition of climate-focused organizers across California's Central Coast from the beaches of Santa Barbara to the redwoods of Santa Cruz.

CENTRAL COAST IIMATE **SUMMIT 2020**

Greenpower refused to let the pandemic get in the way of climate progress. Together with this coalition of local and regional climate organizations, we produced a virtual, three-part Central Coast Climate Action Summit to help our region build just, equitable, community-based solutions to climate change. COMMUNITY CHOICE ENERGY

Greenpower, along with committed activists, won an important victory for clean energy and community choice by successfully convincing Monterey Bay Community Power (MBCP) to reject nuclear carbon-free attributes and remain 100% carbon-free in its procurement strategy. The new standards improved the environmental performance of MBCP, while supporting its new brand — Central Coast Community Energy (3CE) — and aligning its procurement strategy with its founding mission.



After more than three years of collaboration with Greenpower and the Aromas Progressive Action League, Graniterock's A.R. Wilson Quarry received San Benito County's blessing to install 15,000 photovoltaic solar panels, which makes this 5-megawatt solar farm one of the largest private energy projects in California. Its \$15 million commitment will allow Graniterock to supply well over 50% of the quarry's energy needs with green energy generated onsite, significantly reducing its dependence on fossil fuels. The project is timed for completion in 2022.

Lakota People's

Lakota Peoples Law Project

was born in 2004, when a group of Lakota grandmothers asked us to help them prevent South Dakota's Department of Social Services from removing their grandchildren from their families. Our focus expanded in 2016, when the Dakota Access pipeline threatened the Lakota's sacred lands and water. By 2020, we had developed close ties with tribal nations and nonprofit allies, working together to amplify Indigenous voices, replace fossil fuels with renewable solutions, protect the voting rights of Native people, and provide on-the-ground support when and where it's most needed.

Mission: A coalition of Native

and non-Native activists and legal professionals, the Lakota People's Law Project (LPLP) partners with the Lakota people, creating systemic change that supports the sovereignty of the Oceti Sakowin Oyate — the People of the Seven Council Fires. We combine public education, advocacy, on-the-ground organizing, and high-impact legal support to help win justice and secure the Lakota's inherent rights to autonomy and self-determination.





The climate emergency is dire — and the plain fact is that we are running out of time. We need comprehensive solutions, right now, and the Indigenous voice must be at the table to speak for harmony with Mother Earth.

Let's Green CA is launching a statewide campaign calling on California Governor Gavin Newsom to declare a climate emergency followed by executive orders mandating: state funds be used to quickly build infrastructure for electrification; all new green jobs must be union jobs that support families; and that we protect the health and safety of marginalized, frontline communities.

We're collaborating with a renowned green energy research group to produce a white paper identifying the roadblocks to accelerating climate solutions. This paper will help us create new legislation for a much faster solution. We will press forward in 2021 on policy development and collaborative partnerships, and jointly build a grassroots movement that will position the golden state as the climate leader, creating a policy model for other states and nations to follow.

The Lakota People's Law Project's climate action in 2021 includes opposing the Dakota Access Pipeline (DAPL) and other dangerous fossil fuel infrastructure, representing water protectors in court, and supporting renewable energy development on tribal nations. We'll engage Interior Secretary Deb Haaland to implement strategic Native and environmental justice initiatives, we'll champion Native voter protections and combat voting restrictions, and we'll continue to support Standing Rock Nation by providing housing and healthy recreation for its most vulnerable kids. Chase Iron Eyes will continue taking our allies and the Native voice to a national audience in his weekly media show, "Cut to the Chase."
