Message from our Executive Director

Dear Romero Institute family,

In 2021, thanks to your generous support, the Romero Institute — home to the Lakota People's Law Project, Let's Green CA!, and now the RICO legal project — made great strides in our fight for Indigenous rights and a livable planet for future generations.

In the midst of ongoing pandemic challenges, you made sure the intrepid teams at the Romero Institute could press forward and accomplish exciting breakthroughs for the Lakota people, for environmental justice, and for a deep dive into Big Oil's criminal history.

With your help, we ran a get-out-the-vote campaign in the Native communities in Georgia, where a pair of important Senate races went down to the wire. Your support in that moment played a key role in protecting the issues we champion in Lakota Country and nationwide. Your assistance throughout the year also meant we could fight shoulder to shoulder with our partners at Camp Migizi in Minnesota against the dangerous Line 3 pipeline.

With support from you and our entire community of generous Lakota Law members, we also launched a much-welcomed teen center at the Standing Rock Nation in partnership with Hoksila White Mountain, who is committed to traditional Lakota cultural practice and healthy afterschool activities for young people.

On the West Coast, our Let's Green CA! team charged ahead with commitment, introducing progressive climate solutions to achieve carbon-zero as soon as humanly possible. We engaged with the environmental justice community, organized labor, traditional environmental groups, and many others in designing solutions that will rein in the transportation emissions comprising 40 percent of California's carbon footprint. Your contributions are helping us form key alliances and co-create solutions that will be a win for us all.

Knowing that our fossil fuel opponents have deep pockets and won't go away quietly, we also assembled a legal team to drill down on the 60-year history of Big Oil's racketeering crimes against humanity, with a special focus on the major oil companies operating in California, their CEOs, chief stockholders, security departments, and financiers.

In this annual report, you will discover more highlights of our 2021 program work and gain insights into our impacts, financials, and goals moving forward — all of which is empowered by your generous support. Thank you for walking by our side on this sacred journey!

Romero Institute is an interfaith, nonprofit law and policy center based in Santa Cruz, CA. Descended from the Christic Institute and home of the Lakota People's Law Project and Let's Green CA, we defend Indigenous communities and the Earth. For more than 50 years, our leaders have been guardians and advocates for the people. Through public education, grassroots organizing, leadership development, research, investigation, impact litigation, and forward-thinking public policy, we take action where our objectives have the potential for large-scale impact. A Harvard-trained constitutional law attorney, Daniel Sheehan, Esq. serves as the Romero Institute's president, chief council, architect of public policy, and primary spokesperson. Daniel has led or participated in some of the most important public interest cases of the last 50 years, including the Watergate and Iran-Contra Scandals, the Pentagon Papers, and the killing of Karen Silkwood.





RICO Suit

In 2021, the Romero Institute added two more legal experts to join attorney Daniel Sheehan, and they began drafting a 300-page Racketeer Influenced Corrupt Organization Act (RICO) complaint against the six major oil companies presently doing business in California. It's designed to stimulate filings by state attorneys general and U.S. Attorneys against corporations, their CEOs, management officials, principal shareholders and financiers, and the American Petroleum Institute, which conspired with the oil leaders to lie to the American public about the known dangers of fossil fuel emissions causing climate change. RICO is normally used to criminally prosecute the Mob, and addresses violations including conspiracy to commit mail fraud, assassination programs, bribery, witness intimidation, kidnapping, blackmail and other criminal activity.

The Romero Institute team is the only nonprofit group who has ever filed such a civil RICO suit, against the 29 people who were working with Oliver North in the Iran-Contra scandal. Our RICO complaint against Big Oil will be given to the proper officials in California to seat a Grand Jury to review criminal charges.

Special Media Project

In 2021 the Romero's Strategic Investigations Division prepared the investigative memorandum supporting preparation of a twenty four-episode audio podcast and an eight-episode documentary film series setting forth the information that was blocked from being presented to a jury during the Reagan and Bush Administrations. This information reveals a widespread criminal racketeering operation supervised by George H. W. Bush's handpicked director of CIA worldwide covert operations. Crimes include massive heroine and cocaine smuggling, provision of illegal weapons and explosives to fascist organizations around the world, and a planetwide political assassination program, all in support of global dominance of the Earth's resources.

its 2030 climate goals. We cemented a partnership with legendary organizer Dolores Huerta and the Dolores Huerta Foundation to make our Electrify CA! vision a reality.







Let's Green CA! works with regional partners

to ensure justice for frontline communities and support workers in building careers in the green economy.

As Greenpower, we led the charge to form a communityowned renewable energy agency: Central Coast Community Energy. Today, our Let's Green CA! team is working in close partnership with the SLO Climate Coalition to ensure renewable energy development supports working families, treats workers with dignity, and respects the rights of frontline communities.



Ultimately, we aim to codify strong workforce and environmental justice standards at community-owned energy agencies across the state of California.





"Instead of top-down, Let's Green CA! will build solutions to the climate crisis from the ground up. When the California Legislature convenes in 2022, we expect to introduce legislation to electrify California's homes and personal transportation infrastructure over the next decade, remedy historic environmental injustice and ensure good-paying union jobs for the professionals who will build California out of the climate crisis. We're envisioning a future in which we remove toxic fossil fuels from our day to day lives; a future in which our homes and cars are all fossil fuel-free within the next decade."

Lakota Peoples Law Project

was born in 2004, when a group of Lakota grandmothers asked the Romero Institute to help prevent South Dakota's Department of Social Services from systematically removing Native children from their families and tribal communities. LPLP's focus expanded in 2016, when the Dakota Access pipeline threatened the Sioux Nation's sacred lands and water. By 2020, we had developed close ties with tribal nations and nonprofit allies, working together to amplify Indigenous voices, replace fossil fuels with renewable solutions, protect the voting rights of Native people, and provide on-the-ground support when and where it's most needed.

Mission: A coalition of Native and non-Native activists and legal professionals, the Lakota People's Law Project (LPLP) partners with Lakota communities, creating systemic change that supports the sovereignty of the *Oceti Sakowin oyate* — the People of the Seven Council Fires. We combine public education, advocacy, on-the-ground organizing, and high-impact legal support to help win justice and secure the Sioux Nation's inherent rights to autonomy and self-determination.




"A PIPELINE OF ABUSE"





LOOKING FORWARD

Thank you for reading along and supporting us in this journey! We accomplished a lot together in 2021, and with you on our side, we'll continue winning justice for people and the planet in 2022.

In the new year, the Romero Institute will continue our work with the RICO suit and our special media project. Our legal team will present the RICO complaint against the six oil companies in California to the California Attorney General and the United States Attorney for presentation to their respective Grand Juries. Our special media project will work with TV and podcast specialists to craft a plan for a dozen or more media productions exposing the criminal enterprise that prevents the human family from entering into a positive and peaceful future. With truth, we can develop real solutions.

Let's Green CA! has big plans for 2022. At the state level, we've partnered with California State Senator Monique Limón to pass a bill inspired by our Electrify CA! framework into law. On the Central Coast, we're working to codify workforce and environmental justice standards at the community-owned renewable energy agency we helped bring into existence: Central Coast Community Energy. Midyear we will begin drafting the next legislative framework to empower California to reach carbon zero in ten years.

The Lakota People's Law Project will keep assisting frontline communities to end extraction, prevent pipelines, safeguard tribal sovereignty, provide kinship care for Lakota children, and amplify Indigenous voices. Our legal team will submit a Supreme Court *Amicus Curiae* brief on behalf of former South Dakota U.S. Senator James Abourezk, the principal author of ICWA, challenging the Federal District Court ruling declaring ICWA unconstitutional. In collaboration with Indigenous populations, we'll register Native voters and increase democratic participation throughout Lakota Country.

Our logo represents the flame of truth, love, and hope in these turbulent times. Your giving spirit is the air that feeds that flame. Together, we can bring light into dark places and learn to live again in balance with nature and one another. It is up to each one of us, right now, to create a welcoming world for the generations to come. As Pierre Teilhard de Chardin said, "The future of the Earth is in our hands."

Please act now to secure justice for Indigenous people, our Earth's greatest protectors, and our planet.
